Infrastructure Improvement Charge:

Shall only apply to a current approved debt repayment; shall be reflected on the bill for actual debt being applied to, and if possible, along with a payment number being applied to each active account while debt is in place and due. This fee amount shall be assessed by a Board of Water Commission vote after permission of a requested debt article is approved by 2/3rds vote at a Town of Orange Annual or Special Town Meeting in order to satisfy the revenue needed in all, or in part, to repay the approved debt service.
